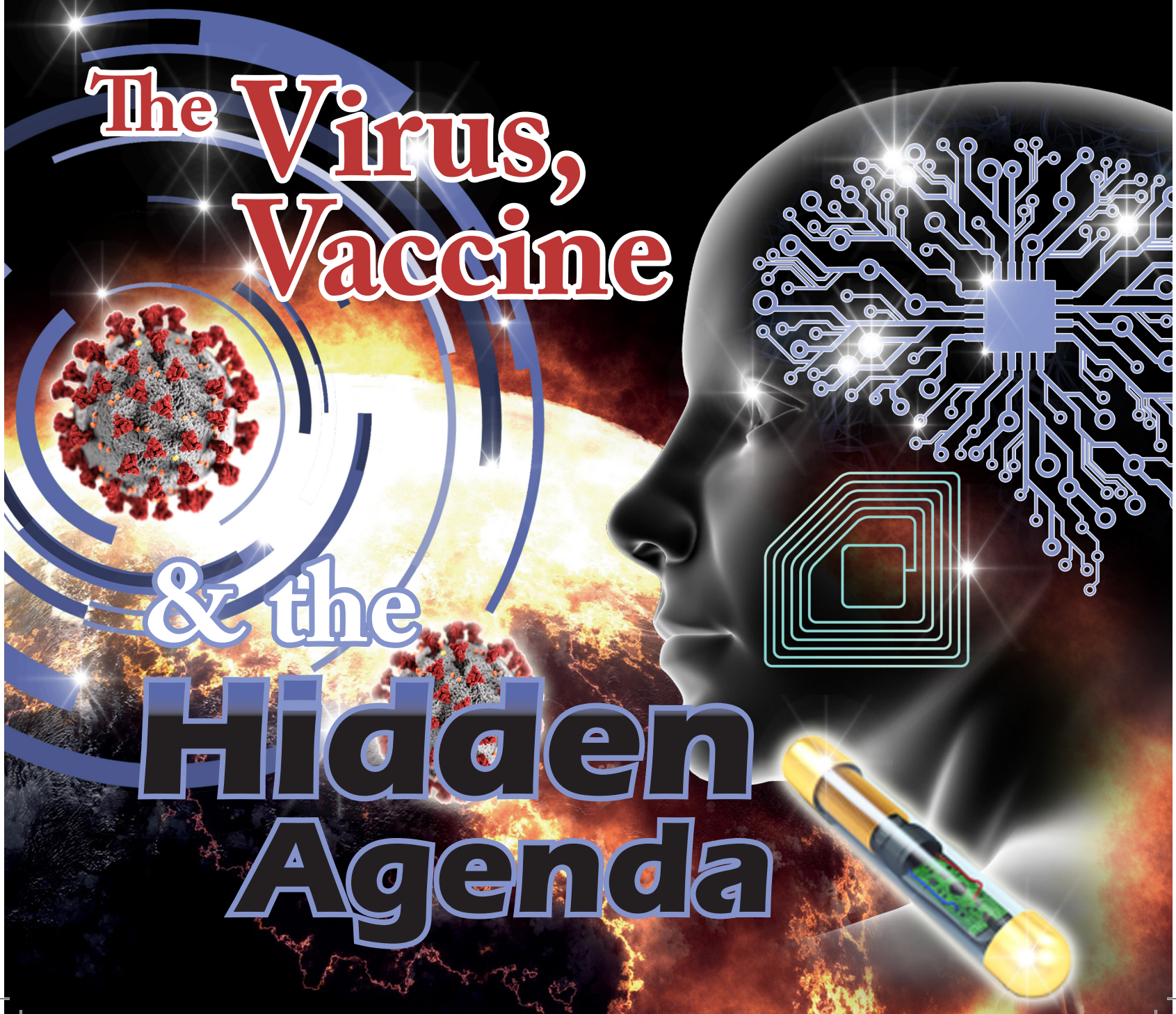

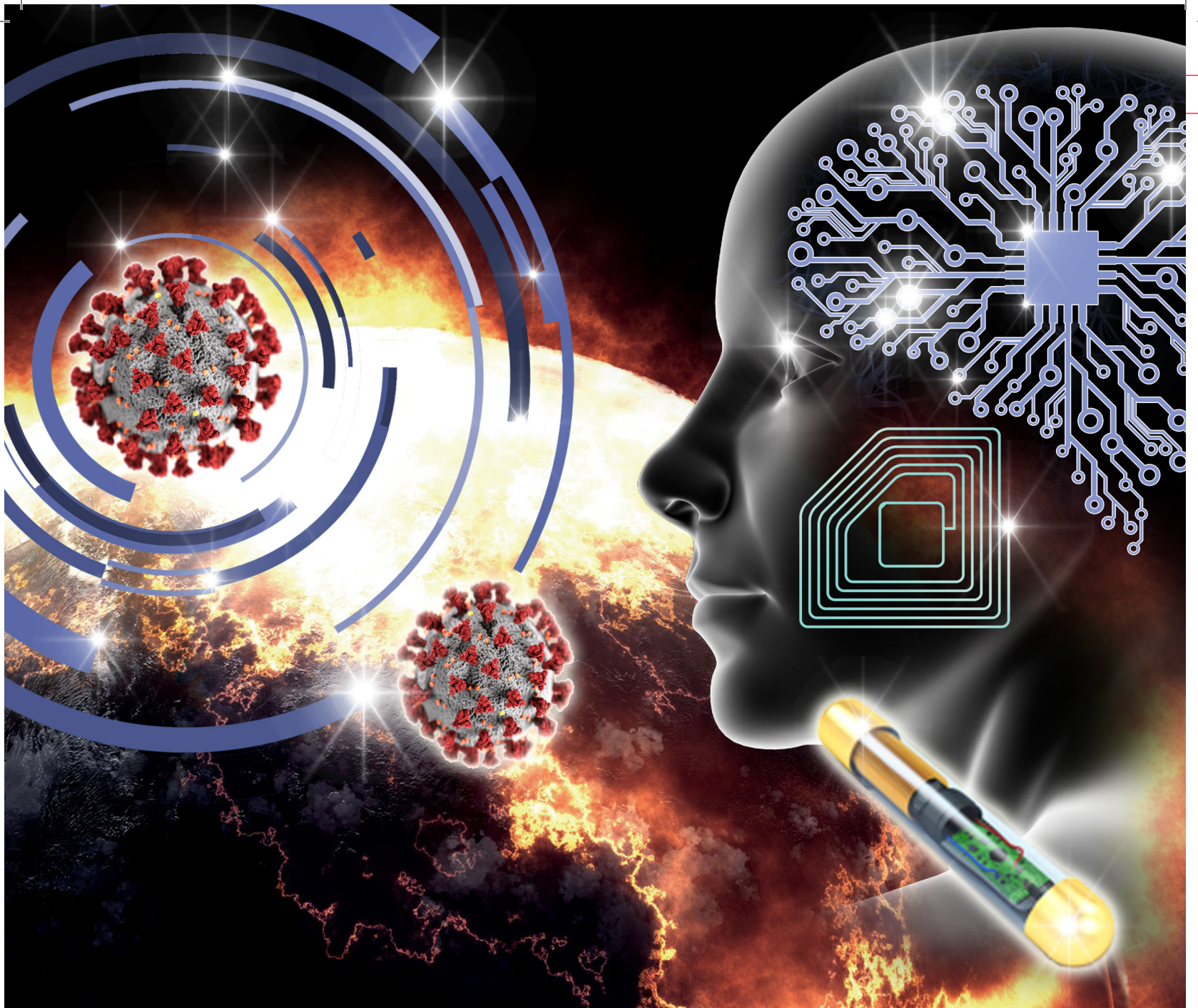

Human 2.0... Will YOU Get the "Upgrade"?

The Globalist cabal and their liberal leaders in the scientific community are working to "upgrade" humanity. According to them, normal, biological humans who are born without genetic modification, manipulation, or added technological "bionics" are Human 1.0. But mankind is about to get a diabolical "upgrade", which is being rolled out within the "Trojan Horse" of COVID-19 and its vaccine.

The VIRUS, the VACCINE & the HIDDEN AGENDA

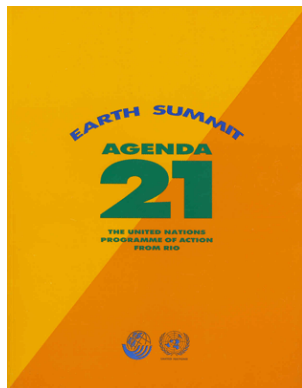
Daniel 8:25—“And through his policy also he shall cause craft to prosper in his hand; and he shall magnify himself in his heart, and by peace shall destroy many..”

By now, we’ve probably all heard of the 1992 Earth Summit and the Globalist, United Nations resolution, which was first presented there, called “Agenda 21”. The name of this infamous agenda was a reference to the target year of 2021, in which the plan for “sustainable development” and a “one-world” style of governance were to start being implemented—globally.

After Agenda 21 was leaked to the public, an extreme backlash from “conspiracy theorists” and conservatives, resulted in the 2021 goal post being “officially moved” to the year 2030. But what if the “move” was a deception? Could the Globalists still be working to implement at least some parts of Agenda 21 in 2021? Could it be that the public is being told one thing, while another is really the truth?

To answer this question, we need to take a look at the original Agenda 21 plan. The Agenda 21 document called for a one world government, one currency, one religion, one military, no private property, mandatory vaccines, microchips for everyone, a Social Credit System, 5G monitoring, among many other draconian regulations.

While we may not see a full readiness for everything on the Agenda 21 list to be implemented, 2021 *is* the year in which mandatory vaccines and microchipping of the



global population are set to be accomplished. Notably, both mandatory vaccinations and microchipping of the human population are listed in the original Agenda 21.

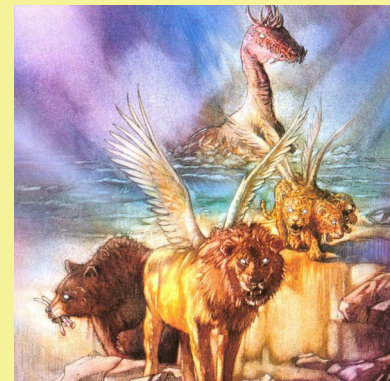
Before we look into this further, let’s pause to see what Bible prophecy has to say about End-time world leadership and how deceptive the leaders will be with the population.

Throughout the writings of the Bible prophets, we see a progression of the final Beast power (*the ultimate Anti-christ*) arising to global dominance in stages (there are four stages in all). The first three of these stages are listed and explained in the yellow panel on the right. In the third stage of the beast’s rise, one evil person will take the “king” position and lead the whole world. This “king” only takes the “throne” after global governance is fully set up, as we see in Daniel 8. Here are a few key Scriptural references:

The Final Beast Rises to Global Power in Stages...

According to Bible prophecy, the final Beast (*which ultimately becomes the Anti-christ*) rises to global power in stages:



STAGE 1: FOUR SEPARATE POLITICAL POWERS—In the first stage, the final Beast is shown in Daniel 7 as four separate beasts, which are four separate “kings” (political powers). These four beasts have had a past application, being Babylon, Medo-Persia, Greece, Rome and Papal Rome. But, as prophecy is cyclical, in the Last Days, the four beasts of Daniel 7 are the permanent security members of the United Nations.

STAGE 2: ONE POLITICAL WORLD-POWER—In the Last Days the Bible tells us the world will be controlled by a unified, one-world power, represented in Revelation 13:2 as a terrible beast. This beast has parts of him that are recognizable as the Daniel 7 beasts. In fact, this final beast is really a union of the previously separate political powers, which are all joined into one, globally dominating power, in the second stage of the beast’s rise.

STAGE 3: RISE OF THE ANTI-CHRIST PERSON—One evil person takes the “king” position as the leader of this global, political power. This person is described in Daniel 8:23 as “a king of fierce countenance and understanding dark sentences...”

“And in the latter time of their kingdom, when the transgressors are come to the full, a king of fierce countenance, and understanding dark sentences, shall stand up... And through his policy also he shall cause craft to prosper in his hand; and he shall magnify himself in his heart, and by peace shall destroy many...” Daniel 8:23 & 25

The Beast (as the evil Anti-christ person who rules the whole world) will “cause craft to prosper”, (Daniel 8:25). “Craft” in the **Strong’s Concordance** is #H4820, meaning: “fraud, deceit, and treachery.” Daniel 8:23 says that he also will “understand dark sentences”. Interestingly enough, the **Strong’s Concordance** word for “dark” **and** “sentences” is the same word (#H2420). It means that the things the final leadership will tell the people will actually be “a puzzle; hence a trick”.

The expression comes from the root #H2330 meaning “to put forth.” Also, since the same word (#H2420) is used twice, the deception, or “trick”, is to give out double meanings in the same dark sentences. The essence of a covert operation is to give out misleading information (dual information). Thus we see plainly that the political leadership of the Last Days will purposely use deceptive language designed to trick the masses.

Considering this prophetic warning, the idea that the political leadership could be lying about implementing Agenda 21, in 2021—as originally planned—is very probable! And deception is definitely going on, as we will see in this report... Our story begins with the release of the virus which was originally known as the Wuhan Coronavirus, but later

came to be commonly known as COVID-19.

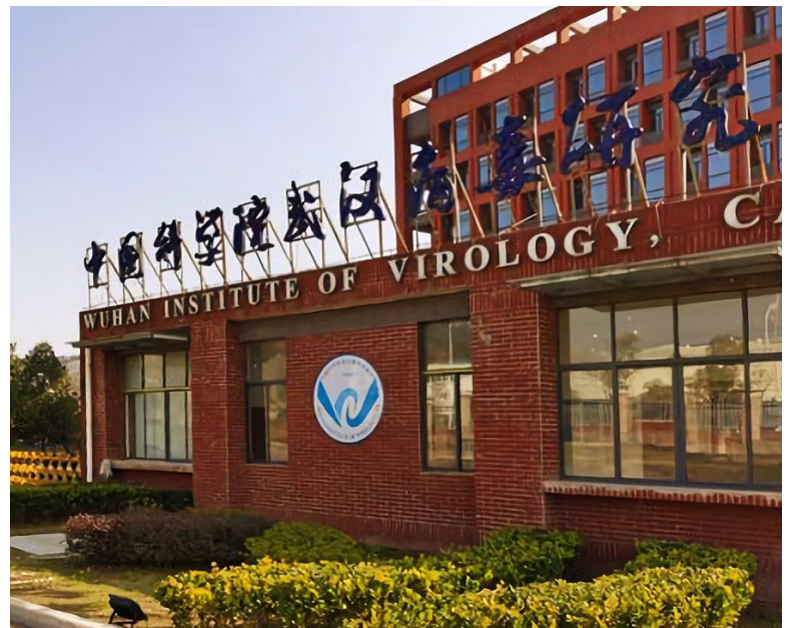
By global reaction, one might at first believe that COVID-19 must be the single most virulent, deadly virus ever to hit mankind! After all, the global response to it has been unprecedented, even though this is not our planet’s first “pandemic” rodeo. **“Countries and territories around the world enforced lockdowns of varying degrees... Mostly, only essential businesses are allowed to remain open. Schools, universities and colleges (as well as recreational venues, churches and other public facilities) have closed either on a nationwide or local basis in 161 countries, affecting approximately 98.6 percent of the world’s population.” (“COVID-19...” UNESCO, March 4, 2020)**

Notably, the COVID-19 response has ranged from ridiculous (like using **antibacterial hand-sanitizers to kill a virus**) to downright draconian (like **educational centers and churches being forcibly closed, and small businesses being bankrupted by the lengthy and mandatory closure**). But what has been most noteworthy about it is that this is the first time the whole world has been impacted by a purported “pandemic”.

Perhaps most sobering of all is the observation that the general public is unquestioningly going along with

whatever “hoops” their leaders demand. Largely, the more time that passes under the dictates of these COVID-19 mandates, the more the general population looks forward to the promised salvation that they are told will come with the soon-to-be-released, COVID-19 vaccine.

And indeed a vaccine is forthcoming. In response to this “fearsome” virus, our government is “fast-tracking” the vaccine’s development. While normally a vaccine takes 5-6 years to develop, test, and finally release for public use, the COVID-19 vaccine is being developed so quickly that it has already been developed and has gone to the third stage of trials in just over three months! No matter how one may feel about vaccinations in



the past, this COVID-19 vaccine should raise some serious questions. How can it possibly be safe with such a fast-tracked development? Actually, many conscientious doctors are warning that it isn’t safe—for four reasons:

1) In the animal testing stage, **the animals who were given the vaccine developed liver problems and organ**

failure. Yet, the vaccine was advanced to the next stage.

2) As Dr. Deborah Tavares reported, **in the human trials 100% of the trial volunteers manifested systemic side-effects from the vaccine.** But still the vaccine is going forward and is slated for general use in 2021 (*Deborah Tavares, "Human 2.0 A Wake Up Call To The World", www.youtube.com*).

3) **Manufacturers of the COVID-19 vaccine, have been legally granted 100% protection from product liability claims.**

This means that the manufacturers have no risk whatsoever for any adverse reactions the public may experience from taking this poorly-tested, fast-tracked vaccine. Naturally, since there is no risk to the manufacturers of future law-suits, public safety is likely threatened by this soon-coming vaccine. But, sobering as these first three concerns are, the fourth issue is the greatest concern of all...

4) **The COVID-19 vaccine and its system of delivery is soberingly unlike any other vaccine ever made before...** It contains a new substance called "Luciferase", and hydrogel (nanotechnology) which researchers warn will genetically modify and "cloud-upload" the vaccinated—transforming the recipients from Human 1.0 to Human 2.0!

Can a vaccine really do that? Crazy as it may sound at first, please carefully consider the evidence...

It doesn't take much digging to

uncover that the vaccine is so much more than a response to a virus. In fact, many warn that the COVID-19 virus may just be the proverbial "Trojan Horse", for a dark and sinister agenda, which is being pushed upon a fearful and unsuspecting world under false pretenses. In fact, there is a growing amount of evidence to suggest fore-knowledge of the "pandemic", indicating that COVID-19 may well have been created and released on purpose.

According to the timeline on the ***World Health Organization's*** (WHO) official website (www.who.int/), the COVID-19 virus was first reported to WHO on December 31 of 2019. The virus was ruled to be an outbreak—a pandemic—of international concern on January 30, 2020. These are the official dates of the virus' timeline, listed upon the WHO website. But what about its "response"?

H.R. 748, which is also known as the CARES Act, is the (COVID-19) Coronavirus stimulus bill, for \$2 trillion dollars, that was signed on March 25, 2020. This bill is the ***response*** to the COVID-19 virus "pandemic".

Naturally, since the COVID-19 virus is new, and since WHO first announced its awareness of this new virus ***this year***, one would expect that the economic stimulus package—which is a ***response*** to the virus—must have been drafted ***after*** the viral outbreak. But that is not the case. In fact, H.R. 748 was first introduced ***in January of 2019***—one full year before the new

virus outbreak occurred.

As is shown on www.Congress.gov, H.R. 748 was originally introduced as a bill on January 24, 2019 by Representative, Joe Courtney, of Connecticut. The fact that the Stimulus ***response*** to the outbreak was introduced a whole year ***before*** WHO says the outbreak was known or identified, gives credibility to the claim that the COVID-19 outbreak may have been a "planned-demic" as many have suggested.

On June 2, of 2020, ***Independent Science News*** released an eye-opening article, titled: "The Case is Building that COVID-19 Had a Lab Origin". As is reported in this article, COVID-19—which is scientifically identified as Sars-CoV-2—is a corona virus which was likely developed in a bio-weapon lab in Wuhan, China.

Notably, Wuhan, which is known to be the point of origin for the COVID-19 virus, is also the site of the Wuhan Institute of Virology (WIV), China's first and only Biosafety Level 4 (BSL-4) facility. (BSL-4 is the highest pathogen security level.) (See the photo on the prior page.)

"The WIV, which added a BSL-4 lab only in 2018, has been collecting large numbers of coronaviruses from bat samples ever since the original SARS outbreak of 2002-2003." As the article further explained, ***"Led by researcher Zheng-Li Shi, WIV scientists have also published experiments in which live bat coronaviruses were introduced into human cells."***

Thus, it would have been no surprise, to the WIV researchers and to all who read their published findings, that coronaviruses, and quite probably the Sars-CoV-2 coronavirus, could be introduced into the human population through infected animals.

But the "conspiracy theory" of a planned out-break really grew hot when many discovered a connection between Bill Gates and the WIV. The Bill and Melinda Gates Foundation are financial supporters of Wuhan University, and are linked to the WIV through funding virus research. Of course, the Gates Foundation denies any connection with the Wuhan Corona-virus (COVID-19), preferring rather to appear as the global benefactors who are helping to quickly develop a vaccine for it. But not everyone is satisfied with the official denials.

Consider the fact that Bill Gates is the biggest donator to WHO. The Bill and Melinda Gates Foundation website states that Gates and his wife donated 2.2 billion dollars to "support world health and population..." This only sounds good until one looks deeper. The "population support" agenda is all about ***reducing*** the world's population to become what they call "sustainable".

Remember the Georgia Guidestones? The Georgia Guidestones are a huge granite artifact in Elbert County, Georgia.

(continued from page 7) The Georgia Guidestones are sometimes referred to as the “American Stonehenge”. The message which the monolith proclaims is the Globalists’ plan for the New World Order. There are ten rules—known as the “10 Commandments” of the New World Order (www.wired.com/2009/04/ff-guide-stones)— which are engraved on the Georgia Guidestones in eight different languages.

The very first rule makes it clear that the laws of the New World Order are a serious threat to the world. (See inset image below, on the right.) It reads: “Maintain humanity under 500,000,000 in perpetual balance with nature.” Considering that our current world population is about 7.8 billion, this plan to drop the global human population down to only 500 million implies a very serious loss in human life. This is the plan that the Gates Foundation is funding when they donated 2.2 billion to help reduce earth’s population down to a “sustainable” number.

Considering the WHO (and Gates) committment to population reduction, coupled with the implications of the vaccine “fast-track” process, many are concerned about the soon-to-be -released vaccine. An increasing number of “watchmen” are warning that in fact, the vaccine isn’t the humanitarian blessing that it first appears to be. But rather, the COVID-19 virus is being used to bring in a dark, Globalist agenda.

One who is loudly expressing these concerns is Robert F. Kennedy Jr., nephew of former President John F. Kennedy Jr. On the weekend of August 30, 2020, Kennedy spoke to “an enormous crowd in Berlin... as tens of



thousands of Germans joined forces to protest what Kennedy Jr. referred to as Bill Gates’ **“bio-security agenda, the rise of the authoritarian surveillance state and the Big Pharma sponsored coup d’etat against liberal democracy.”** He went on to say that **“the pandemic is a crisis of convenience for the elite who are dictating these policies.”** (Baxter Dmitry, **“Tens of Thousands of Germans Rise Up Against Bill Gates and Big Pharma in Berlin, August 30, 2020, News Punch.”**)

One may quickly understand the connection between the vaccine and “Big Pharma”, but what does the vaccine have to do with “the authoritarian surveillance state”? Many explain that the virus’ common name comes with this implication:

- C** = Certificate
- O** = of
- V** = Vaccine
- I D** = the mandatory **I.D.** chip which is planned to accompany the vaccine.

1 = (A is the 1st letter)
9 = (I is the 9th letter)
 In other words, the name COVID 19 stands for Certificate of Vaccination – ID. And the 19 stands for the letters A and I—or A.I. (*Artificial Intelligence*).

As was mentioned before, the COVID-19 vaccine is a NEW vaccine, unlike any we have ever seen before. To see the full impact of the Agenda 21 plans coming out in this vaccine, we first need to understand a bit more about the vaccine ingredients, and the companies who are manufacturing it.

One new and concerning ingredient in the COVID-19 vaccine is hydrogel. Hydrogel is a liquid which contains microscopic “robots”, known as nano-technology. After being injected with hydrogel, humans will be able to connect with the “Cloud” 24-7. What is the “Cloud”? Simply put, the Cloud is the Internet—more specifically, it’s all of the things you can access remotely over the Internet. When something is

in the Cloud, it means it's stored on Internet servers instead of your computer's hard drive. Being injected with hydrogel, as is present in the COVID-19 vaccine, will establish an interface between the human mind/consciousness and the Internet "Cloud".

This plan to connect the mind with the Internet Cloud has been promoted and advanced by two leading transhumanists: Elon Musk and Ray Kurzweil. Musk's company, Neuralink, has not only produced viable advancements in mind-connecting nanotechnology, it has even invented a new chip with hair-like fibers which is installed into the human brain allowing direct brain to computer interface.

As the *Independent* reported in an online article titled: "Elon Musk's Neuralink Plans to Hook Human Brains Directly to Computers", from July 17, 2019: **Elon Musk's secretive neuro-technology startup Neuralink has made its first major public announcement, revealing flexible "threads" designed to link a human brain directly to a computer... Speaking at an event in San Francisco, Mr Musk said the chip will help "preserve and enhance your own brain" and "ultimately achieve a sort of symbiosis with artificial intelligence... The idea of augmenting human capabilities through technology, often referred to as transhumanism, is usually restricted to the realm of science fiction—but Neuralink says it plans to begin clinical trials of the technology next year."**

Notably, 2020 is the "next year" from the date this article posted. And the clinical trials have already begun. The new Neuralink chip (*shown in the image on the right*) has already been installed into the brain of at least one human test subject with "great success".

So what does this have to do with the COVID-19 vaccine? Neuralink's Elon Musk (along with Ray Kurzweil) is behind the development of the vaccine's hydrogel, containing nanotechnology, to track and connect every human recipient with the Internet Cloud.

What are the implications of human-kind becoming linked with the Cloud? For one thing, you would no longer need to carry a smart phone for GPS to know and track your whereabouts. Your location and movements would be constantly known and monitored by unseen and unnamed data watchers. Body information will be completely monitored 24-7, making personal privacy a thing of the past.



Perhaps most concerning of all is that not only will the vaccine's hydrogel nanites completely remove your privacy, they would also allow for transmissions from the Internet Cloud **to** a person's nanite-infested brain. And what kinds of things can "they" (the unspecified data monitors) transmit directly into the minds of the Cloud-linked population? Technological patents and write-ups admit that "they" would be able to use the injected nanotechnology for "mood modification" and other aspects of mind-manipulation.

While for Bible-believing Christians, this all sounds very alarming—and well

it should!—the pressure that humanity will be under to overcome any remaining compunctions and get the injection will be immense. Consider the explanation of Ben Goertzel, founder and CEO of SingularityNET and the chairman of the Artificial General Intelligence Society and the OpenCog Foundation. Goertzel explained why even resistant mankind will get the nanite upgrade:

"Imagine it's eight years from now. All the other kids in your daughter's third-grade class are way ahead of her because their brains are connected directly to Google and a calculator, and they're SMSing back and forth by Wi-Fi telepathy between their brains while

your daughter sits there in class being stunted because she must memorize things the old-fashioned way and can't send messages brain-to-brain." ("Human 2.0 is Coming Faster than You Think..." **Forbes.com**)

But hydrogel is just one of the alarming new ingredients which will be included in the new COVID-19 vaccine. Another element in the vaccine is actually implementing human genetic modification. This element of the vaccine is based upon the technology of Moderna, whose founder is biologist Derek Rossi.

(continued from page 9) Under Rossi's scientific leadership, Moderna specializes in modifying human RNA, putting the human genome through a GMO transformation. How does a change in the human RNA affect DNA? RNA stands for ribonucleic acid, which is a nucleic acid that is present in all living cells. Its principal role is to act as a messenger carrying instructions from DNA for controlling the synthesis of proteins. In other words, changes to the human RNA can affect permanent changes to the DNA of a person.

Because the new COVID-19 vaccine will be modifying the human RNA of the vaccine recipients, the vaccine is called **mRNA-1273**. As the National Institutes of Health announced on July 27, 2020:

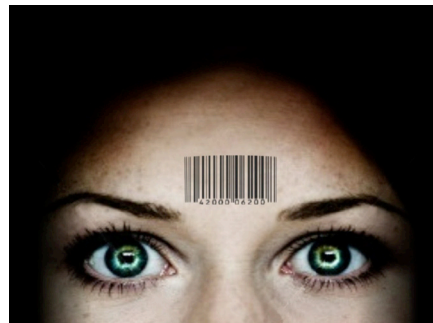
A Phase 3 clinical trial designed to evaluate if an investigational vaccine can prevent symptomatic coronavirus disease 2019 (COVID-19) in adults has begun. The vaccine, known as mRNA-1273, was co-developed by... Moderna, Inc., and the National Institute of Allergy and Infectious Diseases (NIAID), part of the National Institutes of Health (a governmental agency). The trial, which will be conducted at U.S. clinical research sites, is expected to enroll approximately 30,000 adult volunteers..." (www.nih.gov)

And what is the spiritual significance of a vaccine which modifies the human RNA—ultimately changing the DNA? According to Genesis 1:26-27, mankind was created "in the Image" of God. The text of the genome was written by God, in His language, after His Image. If man re-writes the human genome, could it be that he is tampering with, and possibly erasing, the Creator's Image stamp? Could erasing the Creator's coding from the human play a part in receiving the Mark of the Beast? It's a

serious question with potentially deep and lasting spiritual implications. Yet the vaccine manufacturers and supporters are not telling the mainstream masses just what this new COVID-19 vaccine is designed to do or how permanently and deeply (on a cellular level) they will be changed by it.

Additionally, the COVID-19 vaccine will contain the Luciferase enzyme. Proponents suggest that the spiritual name bears no spiritual connection, but rather refers to the bioluminescent agent which the vaccine will carry in order to mark or tattoo the skin. This branding tattoo or mark will serve as proof that an individual has received the soon-to-be-released-and-quickly-made-mandatory vaccine.

Considering how the draconian Agenda 21 plan is coming quickly to fruition through the Globalists' response to COVID-19, we may more fully understand Robert F. Kennedy Jr's warning about "Bill Gates' "**bio-security agenda**,



the rise of the authoritarian surveillance state and the Big Pharma sponsored coup d'etat against liberal democracy (reference on page 8).

If all of these concerns are not enough to give believers pause before joining the rush to upgrade to Human 2.0, some are suggesting that there's even a connection between the vaccination and the Mark of the Beast!

Most believers have long known the spiritual application of the Mark of the Beast. Spiritually, the Beast's Mark is found in the false days and ways of worship. But most Bible prophecy has **both** a spiritual (figurative) **and** a literal fulfillment. Could this be true of the Mark of the Beast? And if so, could there really be a connection between the COVID-19 vaccination process and the physical Mark of the Beast? Certainly it is vitally important that we **know** the answer—beyond question! Scripture plainly teaches that all who will accept the Mark of the Beast will have also received a non-refundable ticket to Eternal Death.

"...If any man worship the beast and his image, and receive his mark in his forehead, or in his hand, the same shall drink of the Wine of the Wrath of God, which is poured out without mixture into the Cup of His Indignation; and he shall be tormented with fire and brimstone in the presence of the holy angels, and in the presence of the Lamb." *Revelation 14:9-10*

We cannot afford to have any aspect of the Beast's Mark sneak up on us, unawares! If people receive the Mark of the Beast by misidentifying it, this would be evidence of the worst kind of deception. But, as we have already read in Daniel 8:23 and 25, deception is foretold to be the reason many will ultimately be destroyed.

With prayer and careful Scriptural study, let us then set aside our possible pre-conceived ideas and carefully examine the COVID-19 vaccination. Let us see whether the proverbial "shoe fits". To do this, we need to examine all of the Scriptural references to the Mark of the Beast, comparing its characteristics with the upcoming vaccination process.

Characteristic #1: the Mark of the Beast will be received in the forehead and/or in the right hand.

“And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads.” Revelation 13:16

It is notable that the vaccination process will involve an identification “mark”. The two main methods of injecting the vaccination both involve leaving a “mark” that serves as proof of vaccination.

1mm tattooed mark may be difficult to see with the naked eye, but special scanners which detect and read the Luciferase enzyme tattoo are slated for installation in major thoroughfares and shopping centers.

The second vaccination delivery option will be a newly designed syringe, which comes pre-filled with both the COVID-19 vaccine and an ID chip. The injection will administer the vaccine and RFID (Radio-frequency Identification) chip simultaneously, into the right hand of the recipient.

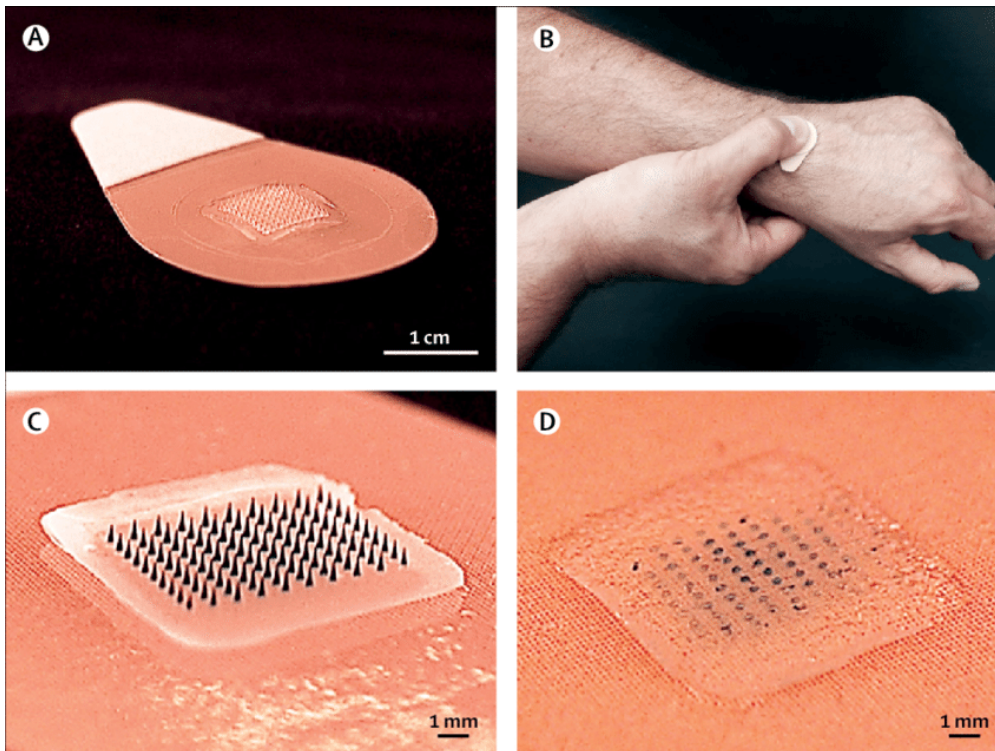


injection devices starting by October 2020.”

In the contract with ApiJect, the US government has already ordered 500,000 of the new, pre-loaded syringes. Notably also, the new RFID chip (which is the size of a grain of rice), is to be injected into the hand, as shown in the above image. Unlike the hydrogel, which is designed for Cloud-tracking and interface, the RFID chip would serve as a total personal identification system. Companies, would chip their employees to allow only authorized personnel access to their facilities. This chipping has already begun in Sweden where the RFID chipping is already required for the employees of many major corporations.

Chipped people would no longer need to carry their wallets, as the near-future society is planned to be “cashless”. People will simply wave their chipped hands over chip-reading receivers in order to collect their digital paychecks and to pay for goods online and in their local stores. Future cars are intended to be made “theft-proof” by removing keys from the ignition system design and replacing them with hand-chip readers, keyed to each owner’s personal RFID chip.

The first vaccination delivery option is set to be the microneedle platform. In this option, citizens would be able to self-vaccinate by simply applying a band-aid containing small fang-like micro-needles which would come pre-loaded with the COVID-19 vaccine. (See Figures A through D, above.)

The final mark, which serves as proof of vaccination, is a small tattoo on the hand, as shown in figure D, above. This

As Department of Defense spokesman, Lt. Col. Mike Andrews, explained on May 12 of this year: **“Today the Department of Defense and the U.S. Department of Health and Human Services, announce a \$138 million contract with ApiJect Systems America for “Project Jumpstart” and “RAPID USA,” which together will dramatically expand U.S. production capability for domestically manufactured, medical-grade**

Notably, the RFID chip is to be implanted in one of the very spots—the right hand—where Revelation 13:16 foretold the Mark of the Beast would be placed.

But what about the forehead? According to Revelation 13:16, the Mark of the Beast will be placed in either the right hand or the head. Could that prophetic location be covered with Elon Musk's new mind-chip, explained on page nine of this article? It's a noteworthy consideration... Let's examine the next mark characteristic.

Characteristic #2: the Mark of the Beast is identified with the number 666.

“Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six..” Revelation 13:18

Does the new RFID chip have any connection with the number 666? Actually, there is an interesting connection. Bill Gates' filed for a patent for collecting “body activity data” (*a personal identification system which gathers personal data by being present on/or in the person at all times*) and “cryptocurrency” (virtual or cashless payment. Gates patent number is WO2020060606 (published as WO/2020/060606). Noting the final digits of the patent number, many people are referring to it as “Patent 666”, or “World Order 2020, 666”.

Since this patent for personal body ID was filed, there has been an ongoing outcry warning that the connection with 666 and “body activity data” monitoring, found in

the patent, looks uncomfortably close to the Biblical description of the Beast's Mark. Notably, the title on the “060606” patent clearly reads: “CRYPTOCURRENCY SYSTEM USING BODY ACTIVITY DATA”. The patent allows for the creation of a device that tracks a human's physical activity or reactions to certain tasks using a variety of sensors.

Let's continue to the third characteristic of the Mark of the Beast...

Characteristic #3: the Mark of the Beast will be globally mandatory.

“And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads.” Revelation 13:16

Of course, in the cashless, keyless, pay-by-hand-swipe world that Globalists envision for the future, it is very easy to see how only chipped individuals would ultimately be able to buy or sell.

Frankly, considering the social pressure behind wearing a face mask, one may conclude that the social pressure to receive the vaccine will be even more intense. And remember even if someone opted for the band-aid instead of the syringe chip installation, because of the Luciferase enzyme, those who have received the vaccine will be visibly detectable, as will those who have not.

But could it actually go to the point that our government will force vaccinations? For those in

other countries, check your laws, it may surprise you to find that many laws are already in place making vaccines mandatory, at least in specific cases.

Already, in the US, there are laws in place requiring certain people to be vaccinated. For example, all 50 states have some type of compulsory vaccination laws covering K-12 school children. Additionally, many states have compulsory vaccination laws covering college students.

It used to be that parents could opt their children out of these vaccination requirements under conditions of religious or philosophical exemptions. But in recent years, a growing number of states have eliminated the religious exemption—two of which are New York and California.

States may also have mandatory vaccination laws covering employees in nursing homes and health care facilities. So, as we can see, current vaccination laws already ensure that many will be vaccinated by mandate.

Further, it is expected that legislation will soon require proof of vaccination to obtain a passport, use public transportation, go to a gym, work in large companies where many people work together, or attend public gatherings (such as Church fellowships). It is not too hard to believe that these types of gatherings will soon be prohibited to all unvaccinated individuals. Consider the mandates which were put in place during the COVID-19 “lockdowns”.

Yes, it is quite foreseeable that the COVID-19 vaccination could also fulfill the third characteristic of the Mark of the Beast. And that brings us to the fourth...

Characteristic #4: those who refuse the Mark of the Beast will be unable to buy and sell.

“And that no man might buy or sell, save (unless) he that had the mark, or the name of the Beast, or the number of his name.” Revelation 13:17

We’ve already addressed the Globalists’ plan to chip humanity and move into a fully cashless society. In such a world, the fulfillment of this fourth characteristic would also be accomplished.

Think of it! How many believers today are even considering that the COVID-19 response might be connected with—even the physical manifestation of—the Mark of the Beast!? For many, this possibility is totally unexpected.

We have been diligently watching out for the Sunday Law! Right? Some might even protest, “How can the Mark of the Beast be associated with the COVID-19 vaccine? No one is expecting that! If the vaccine process is the physical Mark of the Beast, people might take the vaccine and get the mark without even realizing they’ve done so!”

The very idea is so... sneaky... Dare we say, that it would even be the epitome of deceptive? But where did believers get the idea that mankind would only receive the

Mark of the Beast by voluntary choice or informed consent? Where does Scripture promise that the Mark of the Beast won’t be put upon those who are deceived and thereby receive it unwittingly?

As sobering as this may be, Bible prophecy actually repeatedly warns against the deception that will come upon humanity in the Last Days. And—while there are numerous warnings against the onslaught of deception in the End-times—there is not one promise that the Mark of the Beast won’t involve deception! Deception is so great in the Last Days that it characterizes nearly every aspect of spiritual darkness. Consider the following Scriptures about the magnitude of the deception:

“And many false prophets will arise and lead many astray... For false christs and false prophets will arise and perform great signs and wonders, so as to lead astray, if possible, even the very elect.” Matthew 24:11 & 24

“Now the Spirit expressly says that in Later Times some will depart from the faith by devoting themselves to deceitful spirits...” 1 Timothy 4:1

“Let no one deceive you in any way. For that day will not come, unless the rebellion comes first...” 2 Thessalonians 2:3

“You are of your father the devil, and your will is to do your father’s desires. He was a murderer from the beginning, and has nothing to do with the truth, because there is no truth in him.

“When he (the devil) lies, he speaks out of his own character, for he is a liar and the father of lies.” John 8:44

“...Evil people and impostors will go on from bad to worse, deceiving and being deceived.”

2 Timothy 3:13

According to Bible prophecy deception is the name of the “game” in the Last Days. Therefore, we must be sober, watchful, and prayerful students of Scripture. Let us not be taken in by any deception, nor locked into a pre-conceived notion which might prevent us from seeing the truth.

The COVID-19 vaccine is coming very soon. As we have seen, this vaccine and its method of delivery have been strategically designed to mark and track the recipients. Unlike any vaccine before it, the all new COVID-19 vaccine is designed to recode your DNA and permanently connect you with the Internet Cloud. It’s the most epic “upgrade” ever unleashed upon humanity since the Fall of man.

And what about you? When you are presented with your turn to “upgrade” from Human 1.0 to 2.0. What will you do? May your decision then be based upon careful study and much prayer. For in so doing, *Yahweh’s* Protection will keep your feet from slipping into deception, destruction, and Death.

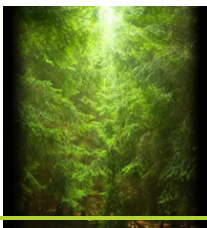
