Session 47: "The Mark of the Beast"

Start Date: March 23, 2021 @ 10 AM (PDT)

Most believers have heard about the Mark of the Beast. As we are studying the four stages of the Beast, we also need to study its Mark... Let's pause our Beast study to get into this related/connected topic.

1) What are the four stages of the Beast:

- Stage 1: Four individual beast (political powers) which work to raise the unified beast
 - (Daniel 7:1-27)
- Stage 2: The four beasts become one global political power
 - (Revelation 13:1-2)
- Stage 3: One evil man rules the global power - worship/money/government
 - (Daniel 8:23-25; Revelation 13:18)
- Stage 4: after deadly wound - demon from the abyss rules for 1260 days
 - (Revelation 11:7; Revelation 17:8)

2) What does the Beast **do**, when it rises to power?

- Dominates/rules the whole world – Revelation 13:3
- Sets up a false religion in which it and the dragon receive worship – Revelation 13:4, 8
- Makes war (persecutes) with the saints – Revelation 13:7
- Blaspheme against Yahweh (claims to be God – John 10:33) – Revelation 13:6
- Invades the "glorious land" – Daniel 11:16 & 41, which is Israel (heart Jerusalem) (Isaiah 8:8; Jeremiah 3:19)
 - The "glorious land" is also called the "goodly land" (see Daniel 11:16 in E-sword).
 - This land is also known as the "pleasant land" – Daniel 8:9 and "the land flowing with milk and honey" – Ezekiel 20:15.

In the End, what happens to this land – Zechariah 7:14?

It is made desolate (connection to the Abomination of Desolation)

- Builds the “ Tabernacle (Temple) of his Palace in the glorious, holy Mountain ” – Daniel 11:45
 - Causes all the world to receive a Mark – Revelation 13:16-17
- 3) What is given to the saved people? the Seal of God
- Revelation 7:3-4
- 4) What is given to those on the beast’s side? the Mark of the Beast
- Revelation 13:16-18
- 5) What does the Bible say about the Seal of Yahweh?
- John 6:27 Sealed means you have everlasting Life assured
 - 2 Timothy 2:19 They have departed from iniquity - sealed means you belong to Yahweh
 - Revelation 7:1-3 Yah's servants are sealed in the forehead before final Judgment (plagues)
 - Ephesians 1:13-14 The sealing is the "earnest" of Redemption (in the Spirit)
 - Ephesians 4:30 Sealed by the Holy Spirit
 - Isaiah 8:16 We are sealed in obedience to the Law (Torah) & Testimony
 - John 3:33 Having the testimony that we believe Yahweh is true
 - Revelation 14:1 We are sealed in the Father's Name
- 6) What does the word “seal” mean in Isaiah 8:16? In other words, once sealed, it is permanent - "to close up; especially to seal: - make an end, mark, seal (up), stop."
- This word also appears in Daniel 9:26. What meaning can we find from this context? Daniel 9:24-26 teaches that sin is ended (the word sealed) at this vision and all visions stop - because it is the end of the world.
- 7) What does the word “seal” mean in Revelation 7:2? Strong's number G4793 a signet (as fencing in or protecting from misappropriation); by implication the stamp impressed (as a mark of privacy, or genuineness), literally or figuratively: - seal.
- 8) What does the word “sealed” mean in Revelation 7:3? From G4973; to stamp (with a signet or private mark) for security or preservation (literally or figuratively); by implication to keep secret, to attest: - (set a, set to) seal up, stop.

noun HISTORICAL

a small seal, especially one set in a ring, used instead of or with a signature to give authentication to an official document.

Ancient kings used signet rings to designate authority, honor, or ownership. A signet contained an emblem unique to the king. Official documents were sealed with a dollop of soft wax impressed with the king's signet, usually kept on a ring on his finger. Such a seal certified the document as genuine, much like a notary public's stamp today. In 1 Kings 21:8, the evil Queen Jezebel took King Ahab's signet ring and "wrote letters in Ahab's name and sealed them with his seal." The ring's stamp gave her letters the king's authority.

The "signet ring," also known as a "seal" comes from the Hebrew word "*hotam*" and the Greek word "*sphragis*" and was used universally in the ancient world. It was a portable instrument used much like we use a signature today, but much more important.

In the End, the Father who claims us is going to be the one we look like in character.



Elements of the Seal are found in Exodus 20:8-11

- Title: Creator of Heaven and Earth

- 9) What does the word “mark” mean, in context of Mark of the Beast? (see “mark” in E-sword in Revelation 13:16). “Mark” is Strong’s Concordance #: G5480, which means “a statue or graven thing”
“a scratch or etching, that is, stamp (as a badge of servitude)... graven, mark.
- 10) What does the Bible say about the Mark of the Beast?
- Revelation 13:16 everyone (poor or rich, powerful or weak) globally will be forced (caused) to receive the mark (you can't drift out of this one)
 - Revelation 13:17 Those who don't get it cannot buy or sell (basically function in society)
 - Revelation 13:18 The Mark of the Beast is connected with the number 666
 - Revelation 14:9-11 Those who receive the Mark of the Beast will also partake of the 7 last Plagues and will receive hell fire... eternal damnation
 - Revelation 15:2 those who get the victory over the Mark are saved

- 12) What is the literal or physical fulfillment of the Seal of Yahweh vs. the Mark of the Beast? To answer this question, consider the following:

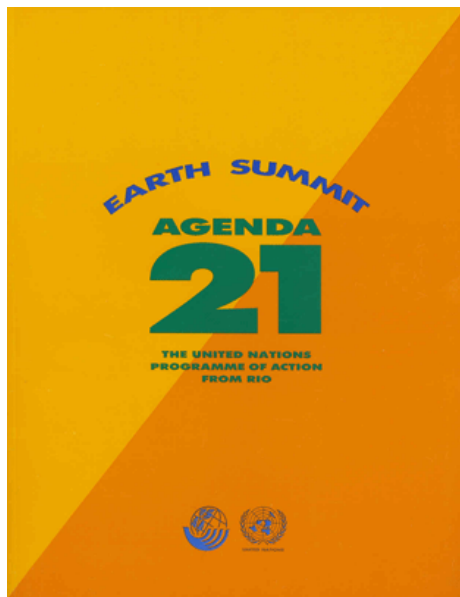
The Globalist cabal and their liberal leaders in the scientific community are working to “upgrade” humanity. According to them, normal, biological humans who are born without genetic modification, manipulation, or added technological “bionics” are Human 1.0. But mankind is about to get a diabolical “upgrade”, which is being rolled out within the “Trojan Horse” of COVID-19 and its vaccine.

The COVID-19 vaccine is a **NEW** vaccine, unlike any other before it. It is being funded by the DOD and mass-produced by MODERNA, which is a company founded upon the modification of human RNA. The vaccine will contain “Luciferase”... We’ll get to what that is and does in the article... It will also contain hydrogel, which is nanotechnology connecting the human mind with the

“cloud”. And it will be delivered by an all new micro-needle platform. The vaccine will upgrade people to Human 2.0...

Let’s take a close look at the vaccine, the agenda, and Bible prophecy...

By now, we’ve probably all heard of the 1992 Earth Summit and the Globalist, United Nations resolution, which was first presented there, called “Agenda 21”. The name of this infamous agenda was a reference to the target year of 2021, in which the plan for “sustainable development” and a “one-world” style of governance were to start being implemented—globally.



After Agenda 21 was leaked to the public, an extreme backlash from “conspiracy theorists” and conservatives, resulted in the 2021 goal post being “officially moved” to the year 2030. But what if the “move” was a deception? Could the Globalists still be working to implement at least some parts of Agenda 21 in 2021? Could it be that the public is being told one thing, while another is really the truth?

To answer this question, we need to take a look at the original Agenda 21 plan. The Agenda 21 document called for a one world government, one currency, one religion, one military, no private property, mandatory vaccines, microchips for everyone, a Social Credit System, and 5G monitoring, among many other draconian regulations.

While we may not see a full readiness for everything on the Agenda 21 list to be implemented, 2021 *is* the year in which mandatory vaccines are set to be accomplished. Notably, mandatory vaccinations are listed in the original Agenda 21.

Before we look into this further, let’s pause to see what Bible prophecy has to say about End-time world leadership and how deceptive the leaders will be with the population.

Throughout the writings of the Bible prophets, we see a progression of the final Beast power (*the ultimate Anti-christ*) arising to global dominance in four stages. In

the third stage of the beast's rise, one evil person will take the "king" position and lead the whole world. This "king" only takes the "throne" after global governance is fully set up, as we see in Daniel 8. Here are a few key Scriptural reference:

"And in the latter time of their kingdom, when the transgressors are come to the full, a king of fierce countenance, and understanding dark sentences, shall stand up... And through his policy also **he shall cause craft to prosper** in his hand; and he shall magnify himself in his heart, and **by peace shall destroy many...**" ***Daniel 8:23 & 25***

What does this mean? The Beast (*as the evil Anti-christ person who rules the whole world*) will "cause craft to prosper", (Daniel 8:25). "Craft" in the ***Strong's Concordance*** is #H4820 _____, meaning: "deceiving; fraud craft, deceit (-ful, -fully), false, feigned, guile, subtilly, treachery."

Daniel 8:23 says that he also will "understand dark sentences". Interestingly enough, the ***Strong's Concordance*** word for "dark" ***and*** "sentences" is the same word (#H2420). It means that the things the final leadership will tell the people will actually be "a puzzle; hence a trick, conundrum, sententious maxim".

The expression comes from the root #H2330 meaning "to put forth." Also, since the same word (#H2420) is used twice, the deception, or "trick", is to give out double meanings in the same dark sentences. The essence of a covert operation is to give out misleading information (dual information). Thus we see plainly that the political leadership of the Last Days will purposely use deceptive language designed to trick the masses.

Considering this prophetic warning, the idea that the political leadership could be lying about implementing Agenda 21, in 2021—as originally planned—is very probable! And deception is definitely going on, as we will see in this report... Our story begins with the release of the virus which was originally known as the Wuhan Coronavirus, but later came to be commonly known as COVID-19.

By global reaction, one might at first believe that COVID-19 must be the single most virulent, deadly virus ever to hit mankind! After all, the global response to it has been unprecedented, even though this is not our planet's first "pandemic" rodeo.

“Countries and territories around the world enforced lockdowns of varying degrees... Mostly, only essential businesses are allowed to remain open. Schools, universities and colleges (*as well as recreational venues, churches and other public facilities*) have closed either on a nationwide or local basis in 161 countries, affecting approximately 98.6 percent of the world’s population.” (“**COVID-19...**” *UNESCO, March 4, 2020*)

Notably, the COVID-19 response has ranged from ridiculous (*like using **antibacterial hand-sanitizers to kill a virus***) to downright draconian (*like educational centers and churches being forcibly closed, and small businesses being bankrupted by the lengthy and mandatory closure*). But what has been most noteworthy about it is that this is the first time the whole world has been impacted by a purported “pandemic”.

Perhaps most sobering of all is the observation that the general public is unquestioningly going along with whatever “hoops” their leaders demand. Largely, the more time that passes under the dictates of these COVID-19 mandates, the more the general population looks forward to the promised salvation that they are told will come with the COVID-19 vaccine.

But what is really going on with the COVID-19 vaccine? Let’s start off with the health considerations... While normally a vaccine takes 5-6 years to develop, test, and finally release for public use, the COVID-19 vaccine was developed so quickly that it was developed and went to the third stage of trials in just over three months!

No matter how one may feel about vaccinations in the past, this COVID-19 vaccine should raise some serious questions. How can it possibly be safe with such a fast-tracked development? Actually, many conscientious doctors are warning that it isn’t safe—for four reasons:

1) In the animal testing stage, **the animals who were given the vaccine developed liver problems and organ failure**. Yet, the vaccine was advanced to the next stage.

2) As Dr. Deborah Tavares reported, **in the human trials 100% of the trial volunteers manifested systemic side-effects from the vaccine**. But still the

vaccine went forward for general use (*Deborah Tavares, "Human 2.0 A Wake Up Call To The World", www.youtube.com*).

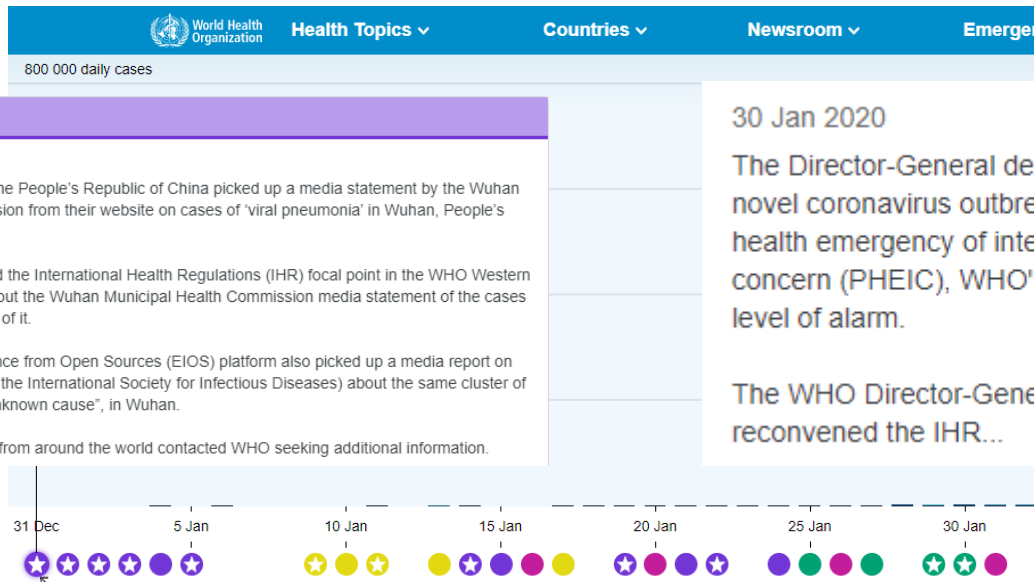
3) **Manufacturers of the COVID-19 vaccine, have been legally granted 100% protection from product liability claims.** This means that the manufacturers have no risk whatsoever for any adverse reactions the public may experience from taking this poorly-tested, fast-tracked vaccine. Naturally, since there is no risk to the manufacturers of future law-suits, public safety is likely threatened by this vaccine. But, sobering as these first three concerns are, the fourth issue is the greatest concern of all...

4) **The COVID-19 vaccine is soberingly unlike any other vaccine ever made before...** It contains a new substance called "Luciferase", and hydrogel (nanotechnology) which researchers warn will genetically modify and "cloud-upload" the vaccinated—this is a giant leap towards transforming the recipients from Human 1.0 to Human 2.0!

Can a vaccine really do that? Crazy as it may sound at first, please carefully consider the evidence...

It doesn't take much digging to uncover that the vaccine is so much more than a response to a virus. In fact, many warn that the COVID-19 virus may just be the proverbial "Trojan Horse", for a dark and sinister agenda, which is being pushed upon a fearful and unsuspecting world under false pretenses. In fact, there is a growing amount of evidence to suggest fore-knowledge of the "pandemic", indicating that COVID-19 may well have been created and released on purpose.

According to the timeline on the **World Health Organization's** (WHO) official website (www.who.int/), the COVID-19 virus was first reported to WHO on December 31 of 2019.



The virus was ruled to be an outbreak—a pandemic—of international concern on January 30, 2020. These are the official dates of the virus’ timeline, listed upon the WHO website. But what about its “response”?

H.R. 748, which is also known as the CARES Act, is the (COVID-19) Coronavirus stimulus bill, for \$2 trillion dollars, which was signed on March 25, 2020. This bill is the **response** to the COVID-19 virus “pandemic”.

Naturally, since the COVID-19 virus is new, and since WHO first announced its awareness of this new virus **this year**, one would expect that the economic stimulus package—which is a **response** to the virus—must have been drafted **after** the viral outbreak. But that is not the case. In fact, H.R. 748 was first introduced **in January of 2019**—one full year before the new virus outbreak occurred ().

As is shown on <https://www.congress.gov>, H.R. 748 was originally introduced as a bill on January 24, 2019 by Representative, Joe Courtney, of Connecticut.

The fact that the Stimulus **response** to the outbreak was introduced a whole year **before** WHO says the outbreak was known or identified, gives credibility to the claim that the COVID-19 outbreak may have been a “planned-demic” as many have suggested.

On June 2, of 2020, **Independent Science News** released an eye-opening article, titled: “The Case is Building that COVID-19 Had a Lab Origin”. As is reported in this article, COVID-19—which is scientifically identified as Sars-CoV-2—is a corona virus which was likely developed in a bio-weapon lab in Wuhan, China.



Notably, Wuhan, which is known to be the point of origin for the COVID-19 virus, is also the site of the Wuhan Institute of Virology (WIV), China’s first and only Biosafety Level 4 (BSL-4) facility. (BSL-4 is the highest pathogen security level.) **“The WIV, which added a BSL-4 lab only in 2018, has been collecting large numbers of coronaviruses from bat samples ever since the original SARS outbreak of 2002-2003.”** As the article further explained, **“Led by researcher Zheng-Li Shi, WIV scientists have also published experiments in which live bat coronaviruses were introduced into human cells.”** (www.independentsciencenews.org/)

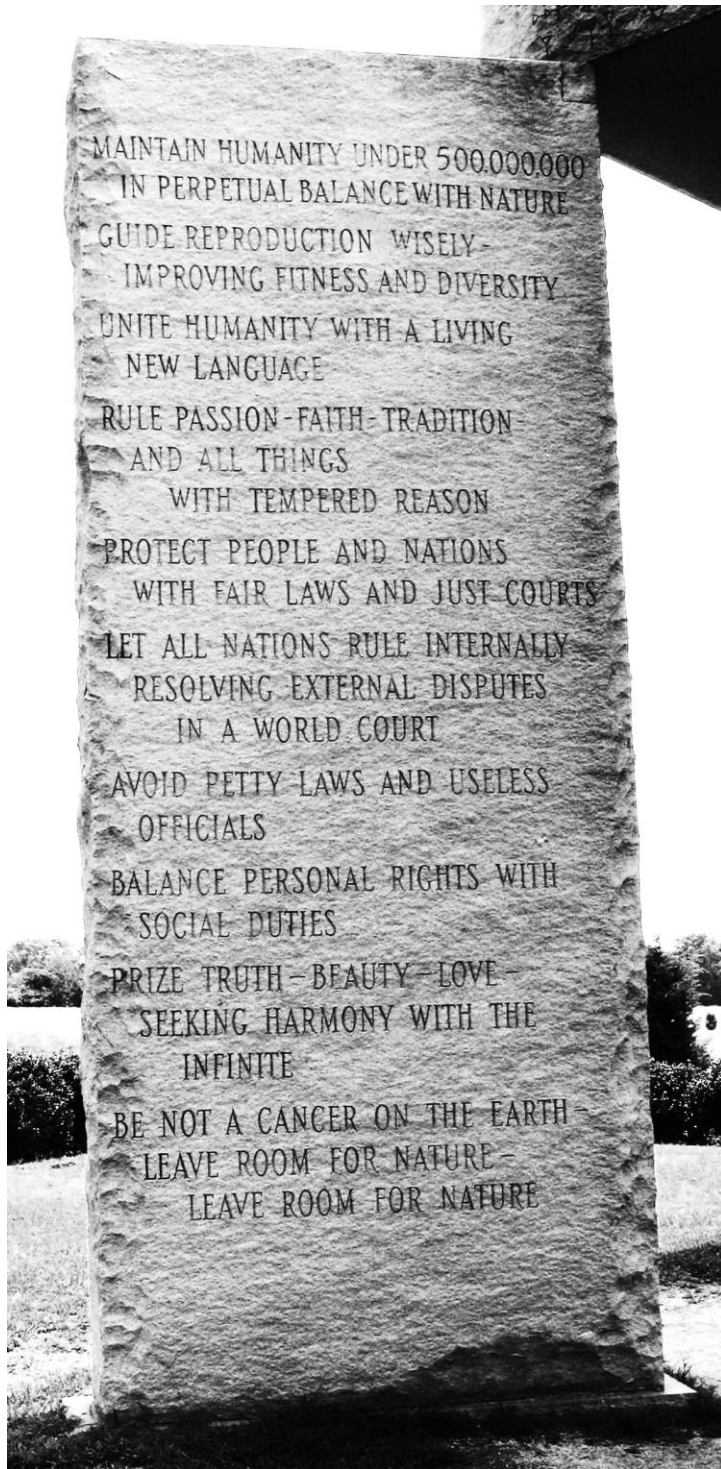
Thus, it would have been no surprise, to the WIV researchers and to all who read their published findings, that coronaviruses, and quite probably the Sars-CoV-2 coronavirus, could be introduced into the human population through infected animals.

But the “conspiracy theory” of a planned out-break really grew hot when many discovered a connection between Bill Gates and the WIV. The Bill and Melinda Gates Foundation are financial supporters of Wuhan University, and are linked to the WIV through funding virus research (See Gates Foundation grants at <https://www.gatesfoundation.org/about/committed-grants>).

Of course, the Gates Foundation denies any connection with the Wuhan Coronavirus (COVID-19), preferring rather to appear as the global benefactors who are helping to quickly develop a vaccine for it. But not everyone is satisfied with the official denials.

Consider the fact that Bill Gates is the biggest donator to WHO. The Bill and Melinda Gates Foundation website states that Gates and his wife donated 2.2 billion dollars to “support world health and population...” This only sounds good until one looks deeper. The “population support” agenda is all about **reducing** the world’s population to become what they call “sustainable”. Remember the Georgia Guide stones? The Georgia Guide stones are a huge granite artifact in Elbert County, Georgia, which are sometimes referred to as the “American Stonehenge”.





The message which the monolith proclaims is the Globalists' plan for the New World Order. There are ten rules—known as the “10 Commandments” of the New World Order (www.wired.com/2009/04/ff-guidestones)— which are engraved on the Georgia Guide stones in eight different languages.

The very first rule makes it clear that the laws of the New World Order are a serious threat to the world. It reads: “Maintain humanity under 500,000,000 in perpetual balance with nature.” Considering that our current world population is about 7.8 billion, this plan to drop the global human population down to only 500 million implies a very serious loss in human life. This is the plan that the Gates Foundation is funding when they donated 2.2 billion to help reduce earth’s population down to a “sustainable” number.

Considering the WHO (and Gates) commitment to population reduction, coupled with the

implications of the vaccine “fast-track” process, many are concerned about the vaccine. An increasing number of “watchmen” are warning that in fact, the vaccine isn’t the humanitarian blessing that it first appears to be. But rather, the COVID-19 virus is being used to bring in a dark, Globalist agenda.

One who is loudly expressing these concerns is Robert F. Kennedy Jr., nephew of former President John F. One may quickly understand the connection between the vaccine and “Big Pharma”, but what does the vaccine have to do with “the authoritarian surveillance state”?

Several sources state that the virus' common name comes with this meaning:

C = Certificate

O = of

V = Vaccine

I D = the mandatory **I.D.** chip which is planned to accompany the vaccine.

1 = (A is the 1st letter)

9 = (I is the 9th letter)

In other words, the name COVID 19 stands for Certificate of Vaccination – ID. And the 19 stands for the letters A and I—or A.I. (*Artificial Intelligence*).

As was mentioned before, the COVID-19 vaccine is a NEW vaccine, unlike any we have ever seen before. To see the full impact of the Agenda 21 plans coming out in this vaccine, we first need to understand a bit more about the vaccine ingredients, and the companies who are manufacturing it.

One new and concerning ingredient in the COVID-19 vaccine is hydrogel. Hydrogel is a liquid which contains microscopic “robots”, known as nanotechnology. After being injected with hydrogel, humans will be able to connect with the “Cloud” 24-7. What is the “Cloud”? Simply put, the Cloud is the Internet—more specifically, it’s all of the things you can access remotely over the Internet. When something is in the Cloud, it means it’s stored on Internet servers instead of your computer’s hard drive. Being injected with hydrogel, as is present in the COVID-19 vaccine, will establish an interface between the human mind/consciousness and the Internet “Cloud”.

This plan to connect the mind with the Internet Cloud has been promoted and advanced by two leading transhumanists: Elon Musk and Ray Kurzweil. Musk’s company, Neuralink, has not only produced viable advancements in mind-connecting nanotechnology, it has even invented a new chip with hair-like fibers which is installed into the human brain allowing direct brain-to-computer interface.

Notably, hair-like silver fibers of nanotechnology may have been placed in at least some of the COVID testing nasal swabs! (See downloaded FB video) For just a few moments, let’s take a look at the COVID test by nasal swabbing, before returning to our study of the COVID-19 vaccine.

To many the nasal-swab COVID-19 test appeared to be more about accessing the blood-brain barrier than virus detection. But for what purpose? Certainly, there is no justifiable reason for accessing the blood-brain barrier—at least there is no reason in the legitimate interests of public health and virus detection.

What is the blood-brain barrier? It is a special system of blood vessels which most swiftly and efficiently interfaces with the brain. As Richard Dainmen and Alexandre Prat explained in their **US National Library of Medicine / National Institutes of Health** online article: “The blood vessels that vascularize the central nervous system (CNS) possess unique properties, termed **the blood–brain barrier, which allow these vessels to tightly regulate the movement of ions, molecules, and cells between the blood and the brain.**”

The idea that the nasal swab might be accessing the blood brain barrier is one which main-stream media attacks and “fact checks” as “wrong”. BBC News responded to this concern by stating:

“The idea you could access the blood-brain barrier through a swab up the nose is a complete misunderstanding of what it is and how it works. The brain has lots of layers of protection. First and mostly obviously is the skull and within that, the brain is further encased in a protective membrane and fluid.”

(BBC News, July 18, 2020 “Coronavirus Tests: Swabs Don’t Damage the Brain and Other Claims Fact-Checked”)

Having read these main-stream “fact-checks” most folks feel foolish for questioning the medical establishment and turn away from the “crazy” conspiracy theorists’ supposedly unfounded ideas. Doctors who have spoken out against the COVID-19 swab are deemed unfit to practice medicine. And life goes on...

But while the mainstream media pokes fun at people who could believe such “foolish ideas” about the nasal swab accessing the blood-brain barrier, recent medical studies admit that the blood-brain barrier can be breached through the nasal passageway! As was reported in the online **medical journal**,

ScienceDaily.com, in an April 24, 2013 article titled: “Nasal Lining Used to Breach Blood/Brain Barrier”:

“Using mucosa, or the lining of the nose, researchers have demonstrated what may be the first known method to permanently bypass the blood-brain barrier...”

(www.sciencedaily.com/releases/2013/04/130424185207.htm)

In fact, according to Science Daily, the blood brain barrier is accessible through accessing the mucous anywhere in the nasal lining! Thus, as this process has been refined, it is now often not even necessary to insert the COVID-19 testing swab as deeply into the nasal passageway. New testing allows people to just hold the swab against the inside of the nose for 15-30 seconds... Just know, that according to the latest research, even that would allow time for something to be transmitted through the mucous to the blood-brain barrier and then the brain.

Several of those “discredited” doctors are warning that the COVID-19 testing swab kits come loaded with nanotechnology that is designed to transmit something from the cotton swab through the blood-brain barrier and to the brain, during testing. But is there any scientific reason to believe that the COVID-19 testing swabs are doing anything more than absorbing mucous? Are these disparaging doctors unfit to practice medicine, for suggesting that something might be transferred from pre-loaded swabs to the individuals, during testing?

On November 12, 2020, **National Science Foundation** reported, **“Inspired by a parasitic worm that digs its sharp teeth into its host’s intestines, Johns Hopkins University researchers have designed... microdevices that...release drugs into the body. Made of metal and thin, shape-changing film and coated in a heat-sensitive paraffin wax, “theragrippers,” each roughly the size of a dust speck, can carry a drug and release it gradually into the body.”**



This cotton swab contains dozens of the tiny, shape-shifting theragrippers (photo provided by John's Hopkins University). These dust-speck-sized nanites are designed to move and "activate" when they come in contact with mucous **at body temperature**. Once activated, they are designed to move through the body to reach the programmed destination (which in the case of the COVID-19 swab testing is

the brain). The nanites then affix themselves to the lining and release their payload. This is the same kind of nanotechnology that is in the COVID vaccine in the hydrogel!

The nanites, although tiny, are visible in the picture below. But in the COVID-19 testing swabs, the nanites are hidden from view below the visible surface. The reason the swab must either be placed far back in the nasal passageway, **or** must be held against the inside of the nose for a lengthy 15-30 seconds is to allow the nanites to activate in the warm environment of the nasal cavity and to access the mucous for better movement to the intended destination.

Ok... now back to our examination of whether the COVID-19 vaccine may fit the physical fulfilment of the Mark of the Beast... Let's see what else we can find about what they intending to do with this nanotechnology, once inside our brains:

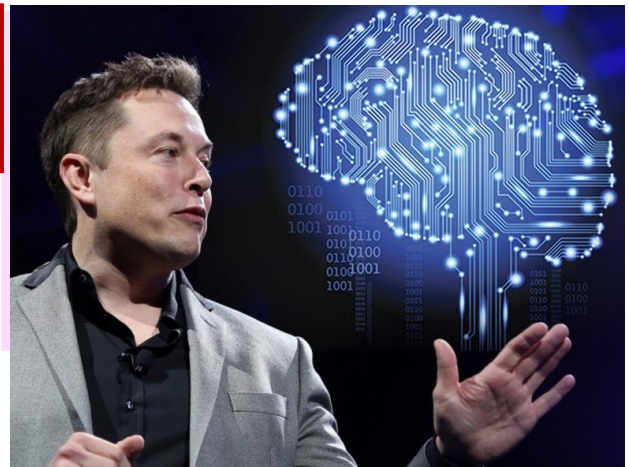

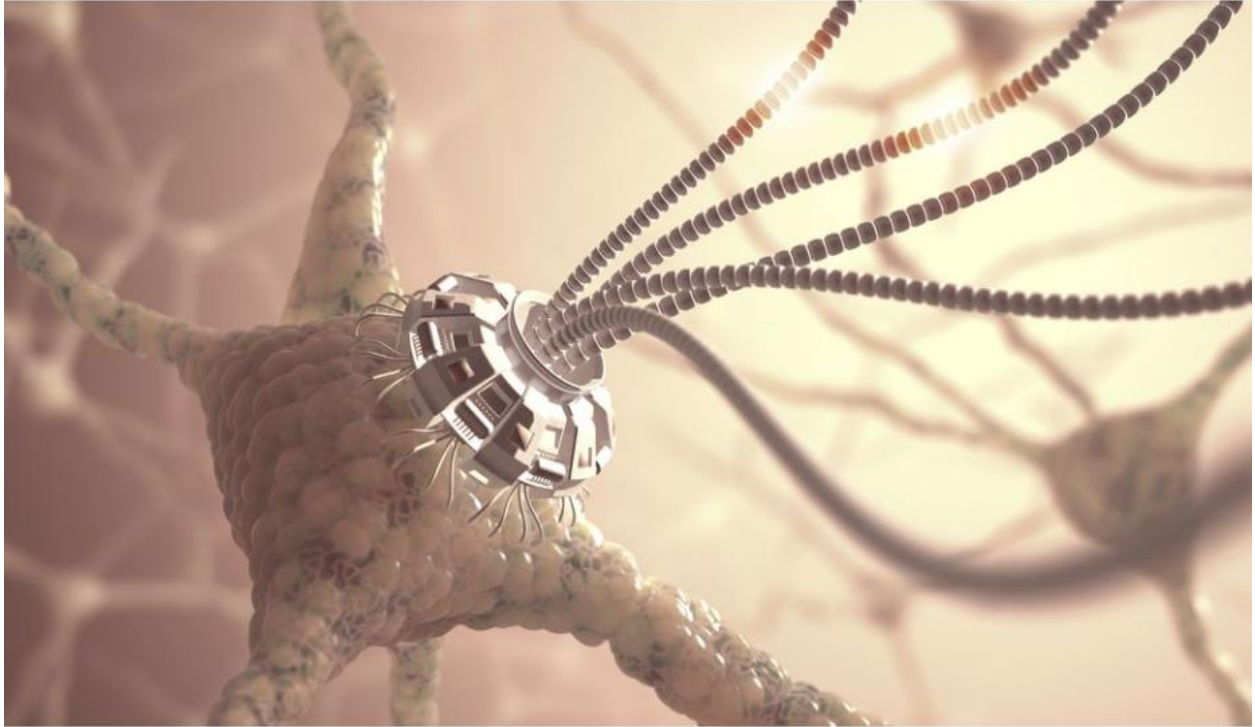
So what does this have to do with the COVID-19 vaccine? Neuralink's Elon Musk (along with Ray Kurzweil) is behind the development of the vaccine's hydrogel, containing nanotechnology, to track and connect every human recipient with the Internet Cloud.

What are the implications of human-kind becoming linked with the Cloud? For one thing, you would no longer need to carry a smart phone for GPS to know and track your whereabouts. Your location and movements would be constantly known and monitored by unseen and unnamed data watchers. Body information will be completely monitored 24-7, making personal privacy a thing of the past.

Perhaps most concerning of all is that not only will the vaccine's hydrogel nanites completely remove your privacy, they would also allow for transmissions from the Internet Cloud **to** a person's nanite-infested brain. And what kinds of things can "they" (the unspecified data monitors) transmit directly into the minds of the Cloud-linked population? Technological patents and write-ups admit that "they" would be able to use the injected nanotechnology for "mood modification" and other aspects of mind-manipulation.

While for Bible-believing Christians, this all sounds very alarming—and well it should!—the pressure that humanity will be under to overcome any remaining compunctions and get the injection will be immense. Consider the explanation of Ben Goertzel, founder and CEO of SingularityNET and the chairman of the Artificial General Intelligence Society and the OpenCog Foundation. Goertzel explained why even resistant mankind will get the nanite upgrade:

“Imagine... All the other kids in your daughter's third-grade class are way ahead of her because their brains are connected directly to Google and a calculator, and they're SMSing back and forth by Wi-Fi telepathy between their brains while your daughter sits there in class being stunted because she must memorize things the old-fashioned way and can't send messages brain-to-brain.” (“Human 2.0 is Coming Faster than You Think...” **Forbes.com**)

But hydrogel is just one of the alarming new ingredients which will be included in the new COVID-19 vaccine. Another element in the vaccine is actually implanting human genetic modification. This element of the vaccine is based upon the technology of Moderna, whose founder is biologist Derek Rossi.

Under Rossi's scientific leadership, Moderna specializes in modifying human RNA, putting the human genome through a GMO transformation. How does a change in the human RNA effect DNA? RNA stands for ribonucleic acid, which is a nucleic acid that is present in all living cells. Its principal role is to act as a messenger carrying instructions from DNA for controlling the synthesis of proteins. In other words, changes to the human RNA can affect permanent changes to the DNA of a person.

Because the new COVID-19 vaccine will be modifying the human RNA of the vaccine recipients, the vaccine is called mRNA-1273. As the National Institutes of Health announced on July 27, 2020:

The vaccine, known as mRNA-1273, was co-developed by... Moderna, Inc., and the National Institute of Allergy and Infectious Diseases (NIAID), part of the National Institutes of Health (a governmental agency).

And what is the spiritual significance of a vaccine which modifies the human RNA—ultimately changing the DNA?

According to Genesis 1:26-27, mankind was created “in the Image” of God. The text of the genome was written by God, in His language, after His Image. If man re-writes the human genome, could it be that he is tampering with, and possibly erasing, the Creator's Image stamp? Could erasing the Creator's coding from the human play a part in receiving the Mark of the Beast? It's a serious question with potentially deep and lasting spiritual implications. Yet the vaccine manufacturers and supporters are not telling the mainstream masses just what this new COVID-19 vaccine is designed to do or how permanently and deeply (on a cellular level) they will be changed by it.

Mainstream media repeatedly asserts that the COVID-19 vaccine does not affect the DNA at all... It only alerts the body's immune system to the virus without giving a person the actual virus... Additionally, the COVID-19 vaccine will contain the Luciferase enzyme. Proponents suggest that the spiritual name bears no spiritual connection, but rather refers to the bioluminescent agent which the vaccine will carry in order to mark or tattoo the skin. This branding tattoo or mark will serve as proof that an individual has received the soon-to-be-released-and-quickly-made-mandatory vaccine.

Considering how the draconian Agenda 21 plan is coming quickly to fruition through the Globalists' response to COVID-19, we may more fully understand Robert F. Kennedy Jr's warning about "Bill Gates' **"bio-security agenda, the rise of the authoritarian surveillance state and the Big Pharma sponsored coup d'etat against liberal democracy"** (reference on page 8).

If all of these concerns are not enough to give believers pause before joining the rush to upgrade to Human 2.0, some are suggesting that there's even a connection between the vaccination and the Mark of the Beast!

Most believers have long known the spiritual application of the Mark of the Beast. Spiritually, the Beast's Mark is found in the false days and ways of worship. But most Bible prophecy has **both** a spiritual (figurative) **and** a literal fulfillment. Could this be true of the Mark of the Beast? And if so, could there really be a connection between the COVID-19 vaccination process and the physical Mark of the Beast?

Certainly it is vitally important that we **know** the answer—beyond question! Scripture plainly teaches that all who will accept the Mark of the Beast will have also received a non-refundable ticket to Eternal Death.

"...If any man worship the beast and his image, and receive his mark in his forehead, or in his hand, the same shall drink of the Wine of the Wrath of God, which is poured out without mixture into the Cup of His Indignation; and he shall be tormented with fire and brimstone in the presence of the holy angels, and in the presence of the Lamb."

We cannot afford to have any aspect of the Beast's Mark sneak up on us, unawares! If people receive the Mark of the Beast by misidentifying it, this would be evidence of the worst kind of deception. But, as we have already read in Daniel 8:23 and 25, deception is foretold to be the reason many will ultimately be destroyed.

With prayer and careful Scriptural study, let us then set aside our possible pre-conceived ideas and carefully examine the COVID-19 vaccination. Let us see whether the proverbial “shoe fits”.

To do this, we need to examine all of the Scriptural references to the Mark of the Beast, comparing its characteristics with the upcoming vaccination process.

Characteristic #1: the Mark of the Beast will be received in the forehead
and/or in the right hand.

“And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads.”

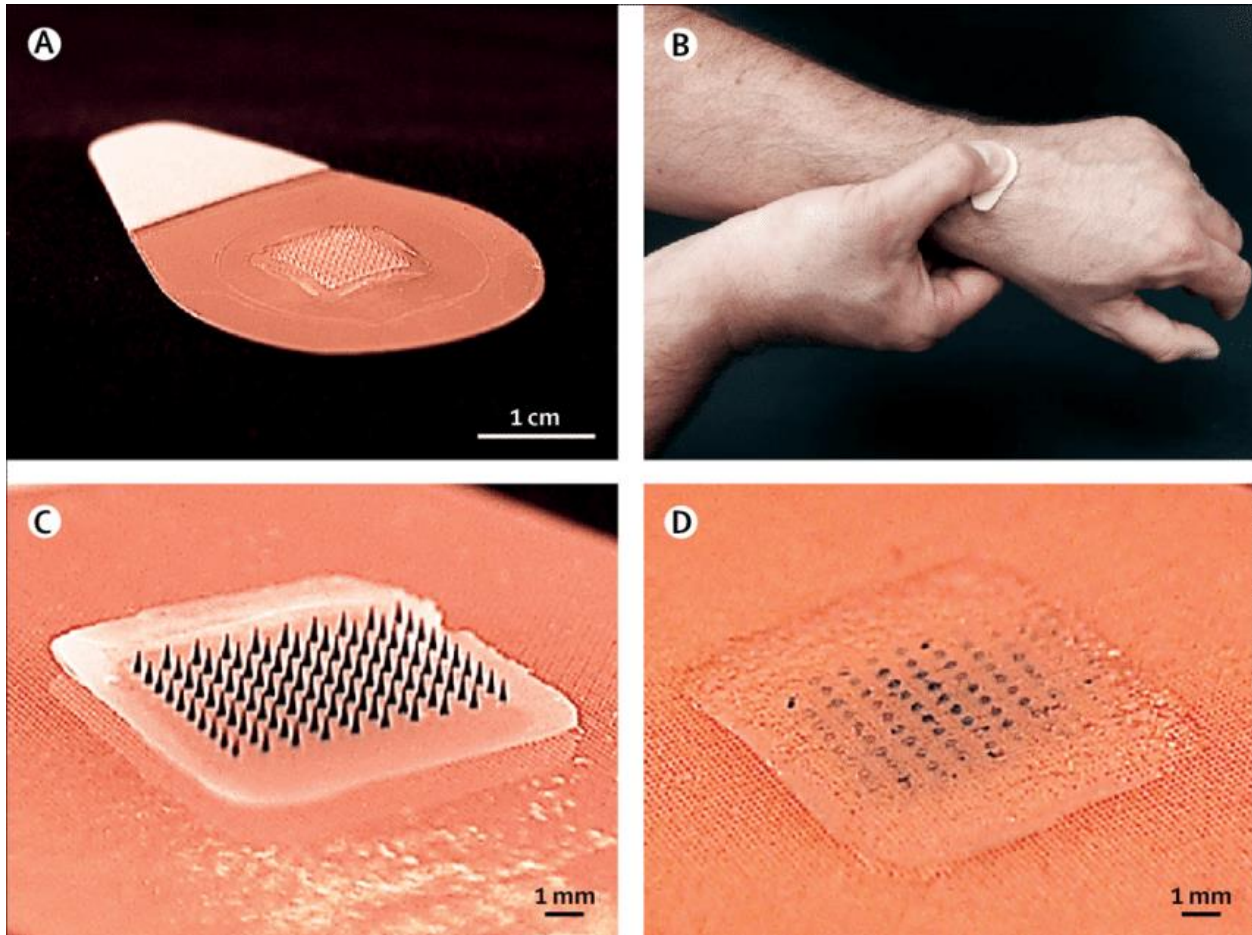
Revelation 13:16

It is notable that the vaccination process is planned to involve an identification “mark”. The two main methods of injecting the vaccination both involve leaving a “mark” that serves as proof of vaccination.

As time goes on, once vaccinated, a person needs to be re-vaccinated. In fact, the COVID-19 vaccination process is planned to be “ongoing” with no set amount of times a person “needs” to be vaccinated. Some conservative watchdogs are concerned that there is an ongoing refinement process in these repeated vaccinations... A refinement which suits the Globalist’s agenda, and not the health of the vaccination recipient.

In the near future, the medical community is expecting a new vaccination delivery option, which may be the microneedle platform. If this option becomes available, citizens would be able to self-vaccinate by simply applying a band-aide containing small fang-like micro-needles which would come pre-loaded with the COVID-19 booster vaccine.

When the bandaid vaccine is applied, it is designed to leave a tattoo-like mark on the person’s hand, which serves as proof of vaccination, as shown in figure D, on the following page. This 1mm tattooed mark may be difficult to see with the naked eye, but special scanners which detect and read the Luciferase enzyme tattoo are slated for installation in major thoroughfares and shopping centers.



The nanites in the hydrogel of the vaccine are designed to serve as a means to monitor the activity and behavior of the vaccinated person. The patent for the nanites states they can be used (by an unnamed group of data-watchers) for “mood modification”, which implies that the Internet Cloud will be in touch with the nanites in the person. Additionally, the nanites are classed as used for “body activity” data. This also bears some connection with the Bible prophecy for the Mark of the Beast.

Characteristic #2: the Mark of the Beast is connected with the number 666 _____.

“Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and **his number is Six hundred threescore and six.**” *Revelation 13:18*

Bill Gates’ filed for a patent for collecting “body activity data” (*a personal identification system which gathers personal data by being present on or in the*

person at all times). Gates patent number is WO2020060606 (published as WO/2020/060606). Noting the final digits of the patent number, many people are referring to it as “Patent 666”, or “World Order 2020, 666”.

Since this patent for personal body ID was filed, there has been an ongoing outcry warning that the connection with 666 and “body activity data” monitoring, found in the patent, looks uncomfortably close to the Biblical description of the Beast’s Mark.

Notably, the title on the “060606” patent clearly reads: “CRYPTOCURRENCY SYSTEM USING BODY ACTIVITY DATA”. The patent allows for the creation of devices that track a human’s physical activity or reactions to certain tasks using a variety of sensors, including nanotechnology, as is present in the hydrogel of the vaccine.
